We want to hear your views about what you think should be included in a proposed public spaces protection order (PSPO) in Croydon town centre.

What is a PSPO?

A PSPO is designed to stop individuals or groups committing antisocial behaviour (ASB) in a public space. The PSPO sets out specific restrictions and requirements, targeting certain behaviours by certain groups at certain times. PSPOs can be enforced by police officers, police community support officers and council officers. Fixed-penalty notices (FPN) of £80 can be issued on the spot. A breach is a criminal offence.
